Madam/Sir,

All Group-A and Group-B Government employees are required to file Annual Immovable Property Return (IPR) of the previous year latest by 31st January of the following year.

2. All Group-A and Group-B (ITOs) officers in the Income Tax Department are already filing their IPRs on SPARROW. During Jan 2025, all Group-B (GZ) employees also filed their IPRs on SAPRROW. As SPARROW-ids have now been created for all employees (except MTS), from Jan 2026 onwards, all Group-B (NG) employees will also file their IPRs on SAPRROW.

3. All IPRs have to be publicly available. NIC has provided six links to view IPRs filed on SPARROW:
